Pursuant to section 1337B(1) of the *Corporations Act 2001* (Cth) (*Corporations Act*), alternatively, section 12GJ of the *Australian Securities and Investments Commission Act 2001* (Cth) (*ASIC Act*), alternatively section 21 of the *Federal Court Act 1976* (Cth) (*FCA*) declarations that Frank Cullity Wilson (**Wilson**):

- (a) by making the Pre-sold Representations, alternatively, not correcting the Pre-sold Representations, engaged in conduct that was misleading or deceptive or that was likely to mislead and deceive in contravention of section 1041H(1) of the *Corporations Act* and/or section 12DA(1) of the *ASIC Act*;
- (b) was involved in the Pre-sold China Continuous Disclosure Contraventions within the meaning of section 674(2A) of the *Corporations Act*; and
- (c) was involved in the Galderma Continuous Disclosure Contraventions within the meaning of section 674(2A) of the *Corporations Act*.

4. Pursuant to:

- (a) section 1041I of the *Corporations Act*;
- (b) section 12GF of the *ASIC Act*; and/or
- (c) section 1317HA of the *Corporations Act*,

orders that Wilson compensate the Applicant and the Group Members for their loss and damage caused by Wilson's contraventions or involvement in Quintis Ltd's (**Quintis**) contraventions of:

- (c1) section 1041E of the *Corporations Act*;
- (d) section 1041H(1) of the *Corporations Act*;
- (e) section 12DA(1) of the *ASIC Act*; and/or



(f) section 674(2A) of the *Corporations Act*.

4AA. The relief claimed against Wilson only by paragraphs 2 to 5 of the Amended Originating Application filed on 5 August 2021 in the proceeding *Davis & Anor v Quintis Limited & Ors* (NSD862 of 2018) (Davis AOA).

#### **Against Both Respondents**

1. Whether the Pre-sold Representations:
  - (a) were made by ~~Quintis and/or~~ Wilson; and
  - (b) if made, were in contravention of: (i) section 1041H(1) of the *Corporations Act* and/or section 12DA(1) of the *ASIC Act*; and/or (ii) section 1041E of the *Corporations Act*.
- 1A. Whether the Pre-sold Representations:
  - (a) were not corrected, qualified or withdrawn by ~~Quintis and/or~~ Wilson and/or were continuing through the Relevant Period; and
  - (b) if not corrected, qualified or withdrawn by ~~Quintis and/or~~ Wilson and/or were continuing through the Relevant Period, were in contravention of section 1041H(1) of the *Corporations Act* and/or section 12DA(1) of the *ASIC Act*.
2. Whether:
  - (a) the Pre-Sold China Information (or any of it, namely the China Risk Information and China Suspension Information) was disclosed at any time prior to 27 March 2017;



- (b) if not, whether section 674(2) of the *Corporations Act* was contravened; and
  - (c) if not, whether Wilson was involved in the contravention within the meaning of section 674(2A) of the *Corporations Act*.
3. Whether:
- (a) the Galderma Information (or any of it, namely the Galderma Assessment of Strategy Information, the Galderma Purchase Cessation Information, Galderma FY16 Information, Galderma FY17 Information, Galderma Intention to Terminate Information and Galderma Termination Information) was disclosed at any time prior to 10 May 2017;
  - (b) if not, whether section 674(2) of the *Corporations Act* was contravened (and if so from which date or dates); and
  - (c) if not, whether Wilson was involved in the contravention within the meaning of section 674(2A) of the *Corporations Act* (and if so from which date or dates).
4. Whether any if so which contraventions alleged against the Respondents or either of them was a cause of any and if so what consequences alleged in paragraphs 15, 16E, 19 and/or 34 of the Statement of Claim.

- 2. Suffered loss or damage by, or which resulted from, the conduct of Quintis and/or Wilson; and



3. Are not any of the following:

- (a) directors or officers, or a close associate of Quintis;
- (b) a related party of Quintis;
- (c) a related body corporate of Quintis;
- (d) an associated entity of Quintis; or
- (e) a Justice, Registrar, District Registrar or Deputy District Registrar of the High Court of Australia or the Federal Court of Australia.
